

Terms and Conditions

BOOSTfit Instructor Training includes access to a back catalogue of BOOSTfit choreography, online support group and regular meetings via zoom. There will be a 1-day training assessment followed by a certificate upon completion of all requirements

Requirements

You will need a Level 2 Movement to Music qualification or equivalent as a prerequisite to become an Independent Contractor with BOOSTfit. We recommend an up to date first aid certificate and full insurance. You must submit any relevant certificates to us. You will need access to a computer and internet to use the routines and Facebook support group.

BOOSTfit code of conduct

This Code of Conduct has been created so that all our instructors could grow successful classes working in harmony with their BOOSTfit team.

- 1) Introduce yourself to any new instructors in the area. Our community is a great way to get class cover and promote BOOSTfit on a wider scale. Remember we are a team, not competitors.
- 2) Unless there has been an official agreement from BOOSTfit in writing, do not launch classes on the same day, time or location as another instructor. This puts you in direct competition and will make it harder for both parties to grow their classes. The decision to allow an instructor to hold a BOOSTfit class under these conditions is at the discretion of BOOSTfit and needs to be confirmed in writing before the class can go ahead.

All new classes must be confirmed via BOOSTfit. They will be added onto the website and an event will be created which you can then share.

- 3) Unless there has been an official agreement in writing do not launch classes at a venue where another instructor is teaching BOOSTfit. Teaching at the same venue will make it difficult for both of you to grow your classes as there will only be a limited number of potential customers.
- 4) Be friendly, professional and live our ethos. Do not badmouth other instructors, companies or class participants (including via social media). Defamation regarding BOOSTfit will not be tolerated. Negative comments reflect badly on you as an instructor and on BOOSTfit as a company. Remember, you're all working together as a team. Should a problem arise please firstly speak to us.
- 5) Do not share inappropriate or political posts on social media via your BOOSTfit/work profile.



BOOSTfit training

To join the training programme the applicant must fill in all forms accurately and ensure relevant qualification are up to date.

A one-off training fee is required in order to complete the BOOSTfit training. Once confirmation of payment is received you will get an email confirmation and access to the training hub.

If you cancel within 7 days of subscribing to BOOSTfit we will refund you the price paid for your training minus any admin fees. If you cancel your training date 4 weeks prior to the day we will charge you a rearrangement fee.

If you cancel your assessment date less than 4 weeks prior to the day a fee will be incurred. All cancelations need to be put into writing and emailed to us.

If you fail to attend the training you will not receive a refund and the next steps will be emailed to you. A fee will be incurred.

If BOOSTfit cancels training, we will inform you as soon as possible in writing to arrange another day. All efforts will be made to make this as convenient to you as possible. No refunds will be available.

BOOSTfit shall not be liable to refund any fees or for any other penalty should courses be cancelled due to war, fire, strike lock-out, pandemic, industrial action, tempest, accident, civil disturbance or any other cause whatsoever beyond our control.

For cancellation due to injury or illness less than 14 days before the course the candidate can be transferred over to another course date upon presentation of a doctor's note. No refund is offered.

Health Conditions

If you have an injury, medical condition or if you are going to be pregnant at the time of the course, please contact us in advance.

Your Monthly Membership

This license does not include any resale of BOOSTfit or its contents; any collection and use of any product listings, descriptions, or prices; any derivative use of BOOSTfit or its contents; or any use of data mining, robots, or similar data gathering and extraction tools. You may not frame or utilise any framing techniques to enclose any trademark, logo, or other proprietary information (including images, text, page layout, or form) of BOOSTfit without our express written consent. Your BOOSTfit Social Media Accounts

Membership & cancellation



All memberships are renewed automatically each month from the date created, until cancelled. Memberships can be cancelled at any time, you will continue to have access to the programme until your subscription month expires. You agree to be bound by the renewal subscription and to pay the fees required for the renewal subscription, which may be higher than the fees you originally paid.

You cannot teach BOOSTfit without an active membership account.

If you wish to reactivate your BOOSTfit membership, your training certificate will remain valid for 12 months from cancelation date. If you wish to return after a 12 month period, you will be required to retrain fully in the BOOSTfit programme. Any fees will be in accordance with BOOSTfit's current prices and previous deals, fees, offers or incentives will not be applicable.

Orders to BOOSTfit
